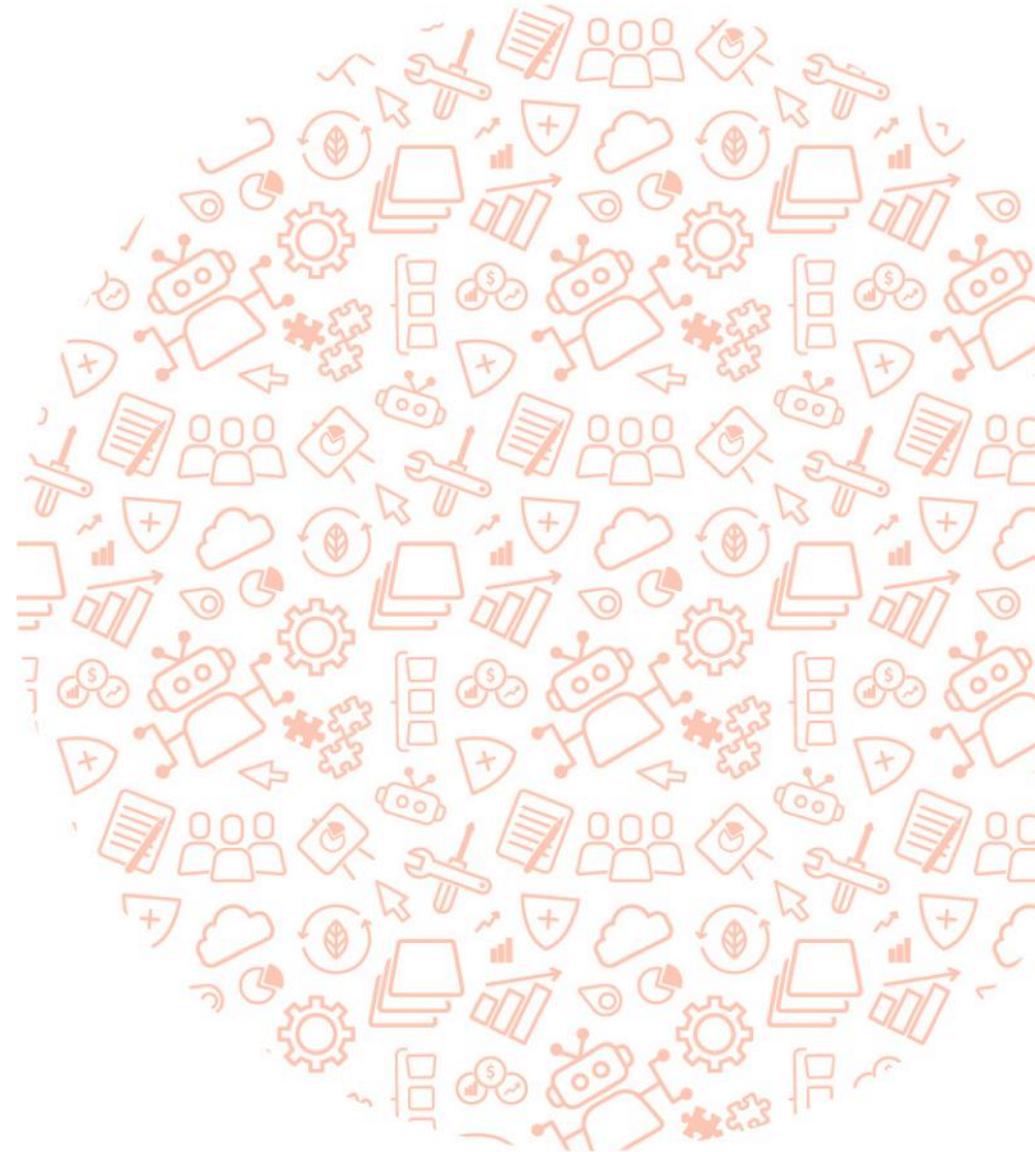

Structured Data Examples in Supply Chain Management

Category	Structured Data
Inventory	SKU numbers, product IDs, quantities on hand, reorder levels
Procurement	Supplier names, purchase order numbers, prices, delivery times
Logistics	Shipping schedules, delivery tracking numbers, freight costs
Production	Bill of materials (BOM), machine utilization rates, production volumes
Sales & Orders	Customer IDs, order dates, quantities, transaction values
Warehouse	Bin locations, pick/pack times, barcode/RFID data
Planning & Forecasting	Historical demand figures, lead times, forecast accuracy metrics
Compliance & Audits	Certification IDs, audit dates, checklist scores

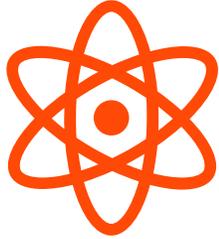
Unstructured Data Examples in Supply Chain Management

Category	Unstructured Data
Product Quality	Images of defective goods, free-text quality reports
Supplier Communication	Emails, phone call transcripts, chat logs
Customer Feedback	Reviews, survey responses, social media comments
Logistics	GPS coordinates, traffic camera footage, driver notes
Document Management	PDFs, scanned invoices, contracts, packing slips
Visual Inspection	Photos or videos of goods, warehouse footage
Market Intelligence	News articles, analyst reports, competitor social media
Maintenance	Technician notes, voice recordings, repair logs

Structured vs. Unstructured Data in Supply Chain Management

Aspect	Structured Data	Unstructured Data
Format	Tabular, relational databases	Free-form, no fixed format
Examples	Product IDs, quantities, delivery dates, pricing	Emails, PDFs, images, videos, call logs
Systems	ERP, WMS, TMS, databases	Email clients, document management systems, file storage
Use Cases	Inventory tracking, order processing, demand forecasting	Sentiment analysis, contract review, visual quality checks
Sources	Spreadsheets, forms, APIs	Scanned docs, social media, cameras, conversations
Analysis Tools	SQL, Excel, BI tools	NLP, computer vision, machine learning, OCR
Ease of Analysis	Easy to medium with correct tools	Complex, requires AI/ML
Value	Operational efficiency, accurate reporting	Contextual insights, risk identification

Agentic Automation

Overview: Outcome oriented orchestration that may use different technologies (agents, GenAI, RPA) to complete a task

Key Takeaways:

- Orchestration technology
- Leverages a wide range of capabilities to complete the goal
- Can actively rebalance based on workload and process requirements

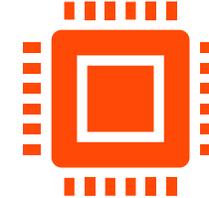


AI Agents

Overview: Software workers that act semi-autonomously to complete a goal, often leveraging GenAI and RPA

Key Takeaways:

- Semi-autonomous automations
- Often task or business specific, requiring context grounding
- Can leverage multiple technologies to complete a goal, but is GenAI reliant



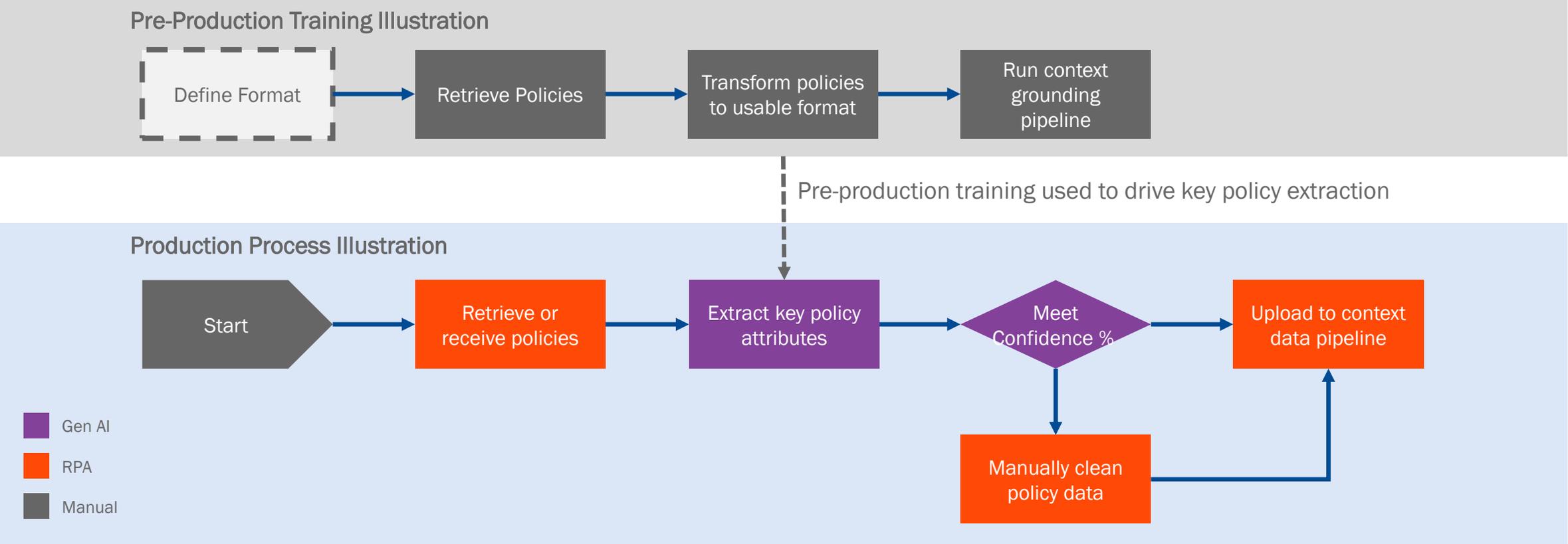
Generative AI

Overview: AI models that complete work in a ‘call & respond’ methodology and typically don’t work autonomously

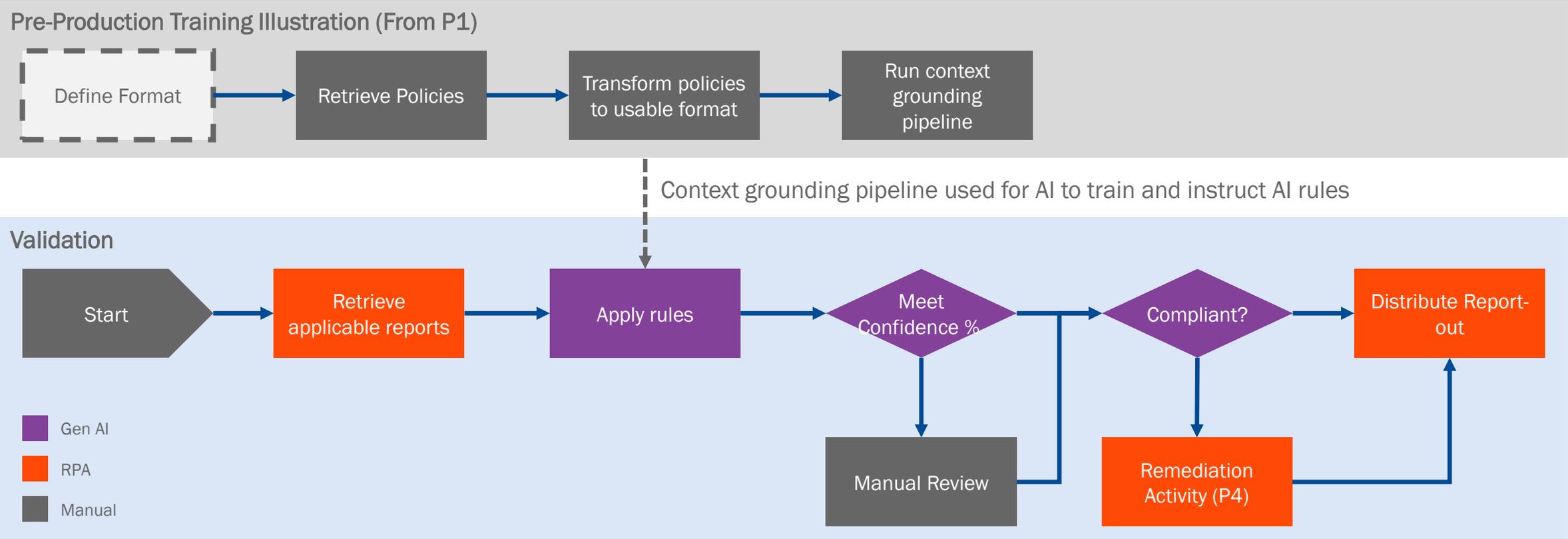
Key Takeaways:

- General AI models
- Can be made task specific through RAG or providing information in prompt
- Currently the most affordable AI technology implementation

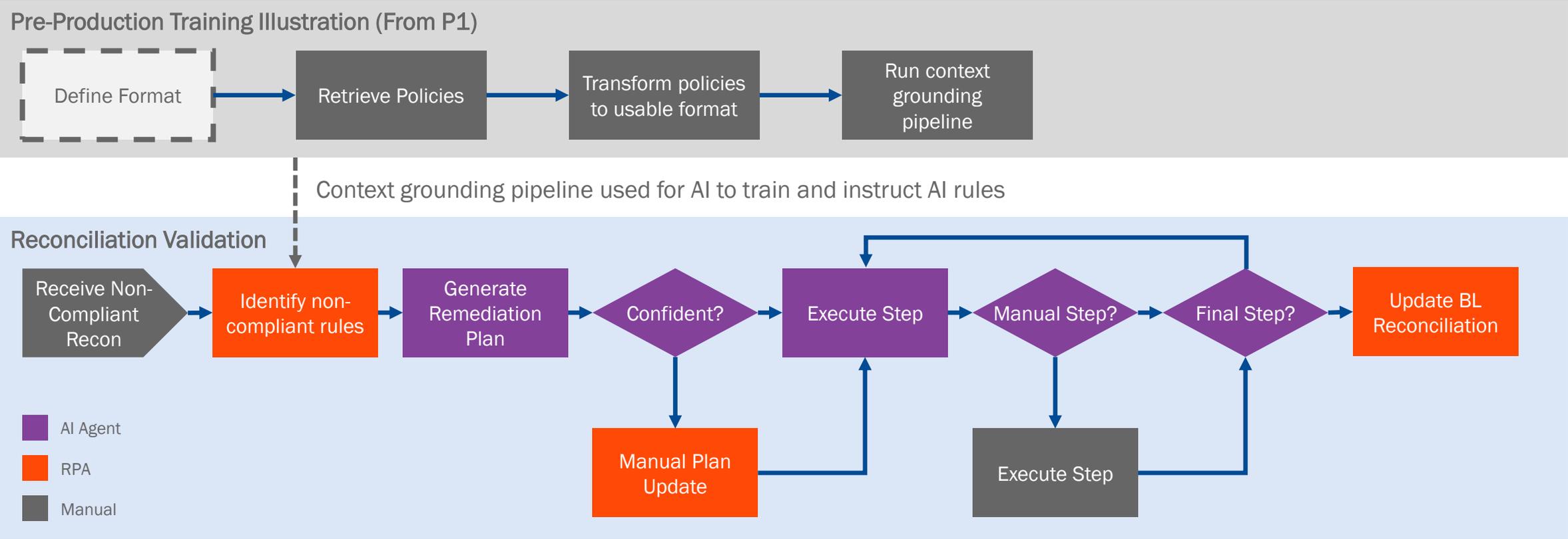
Implemented Solution: Procurement Policy Extraction



Implemented Solution: Procurement Policy Monitoring

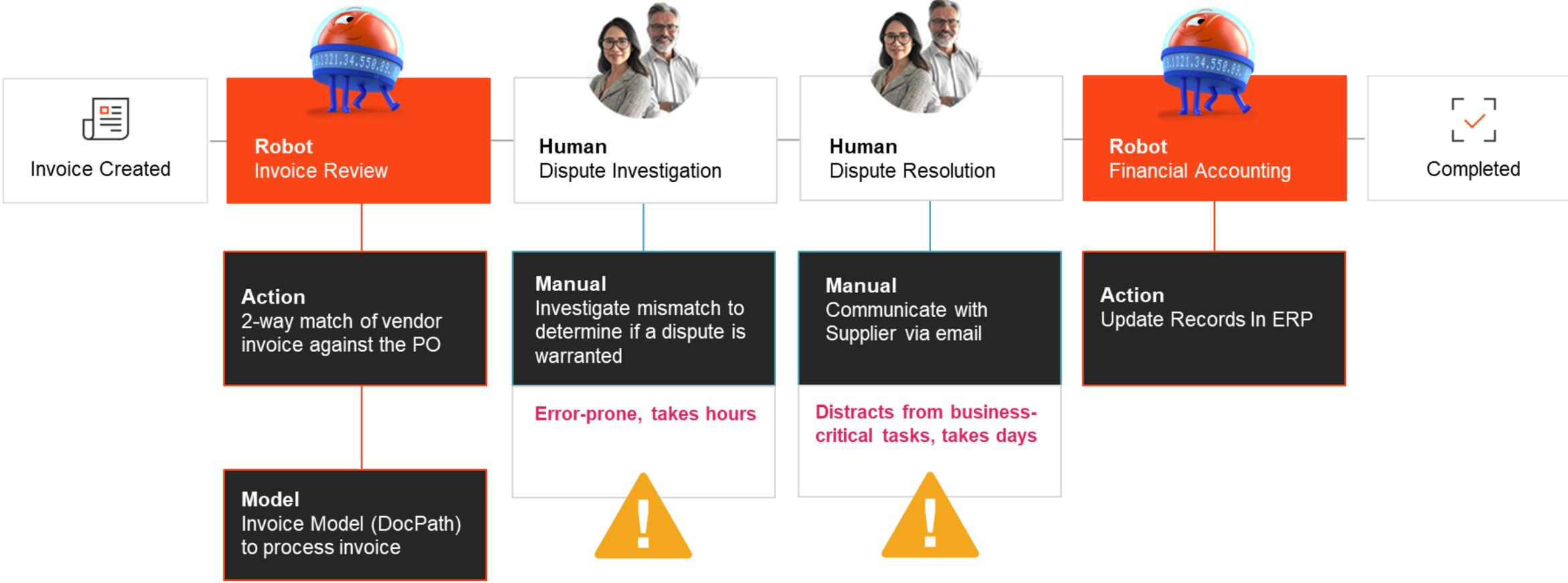


Implemented Solution: Procurement Policy Remediation Activities



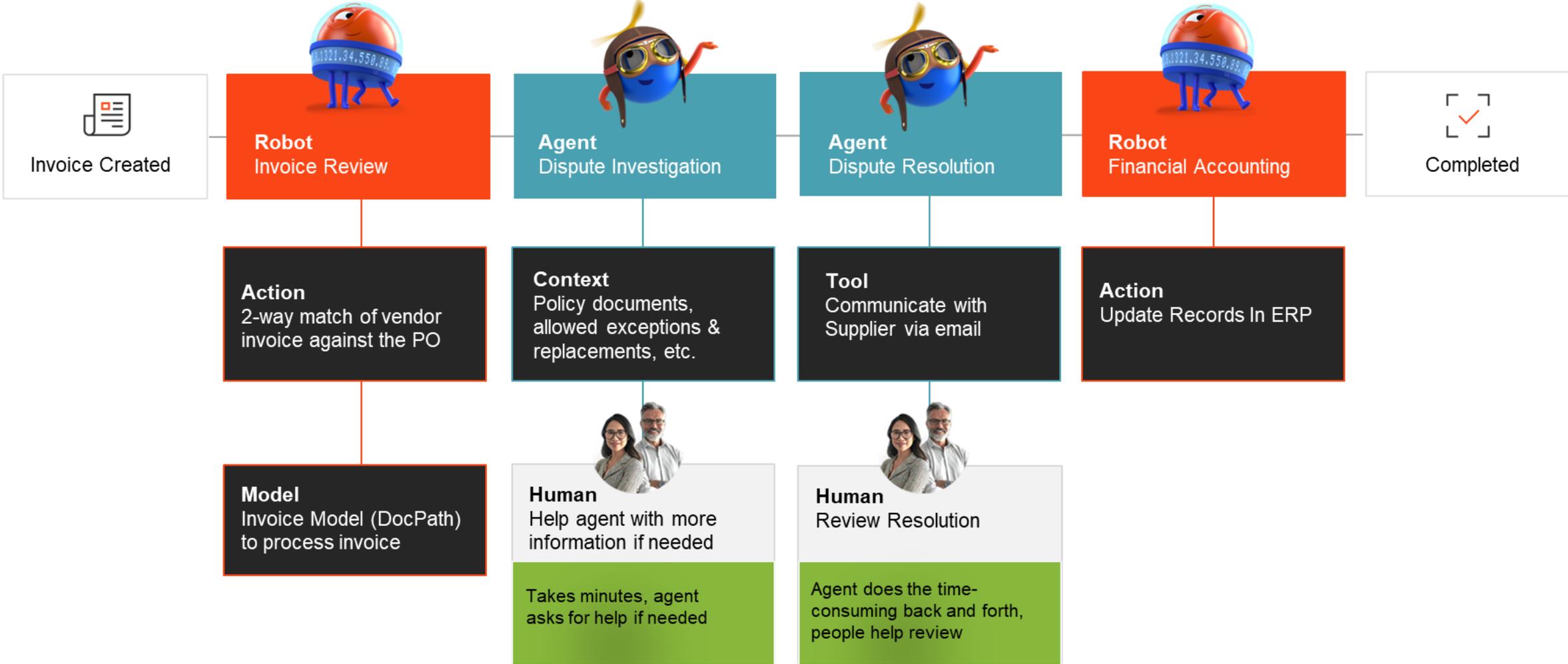
Processing Vendor Invoices

Robotic Workflow

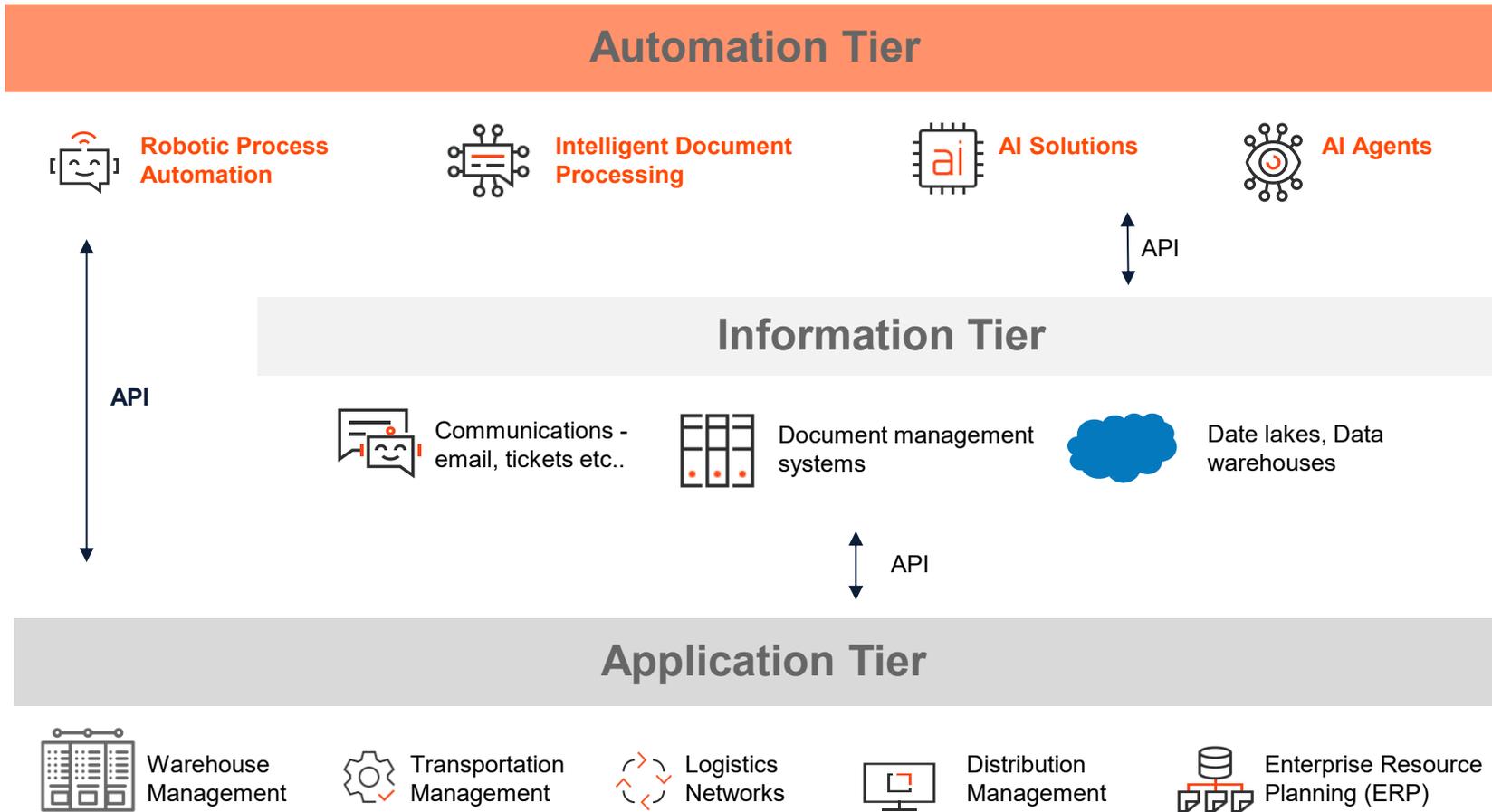


Processing Vendor Invoices

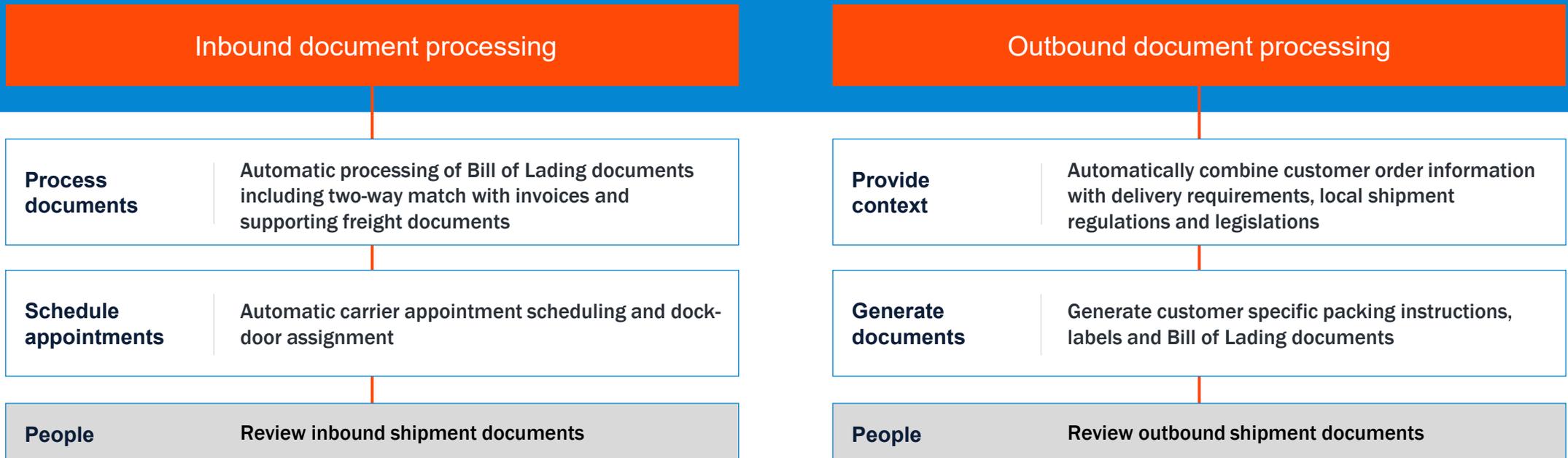
Agentic orchestration principles

- Build a digital twin for your end-to-end processes and organizations
- Leverage the combination of robots, documents, AI solutions and AI agents for agentic orchestration of your processes
- Introduce a continuous learning loop to improve your processes
- Automate first, customize enterprise applications last



Warehouse manager

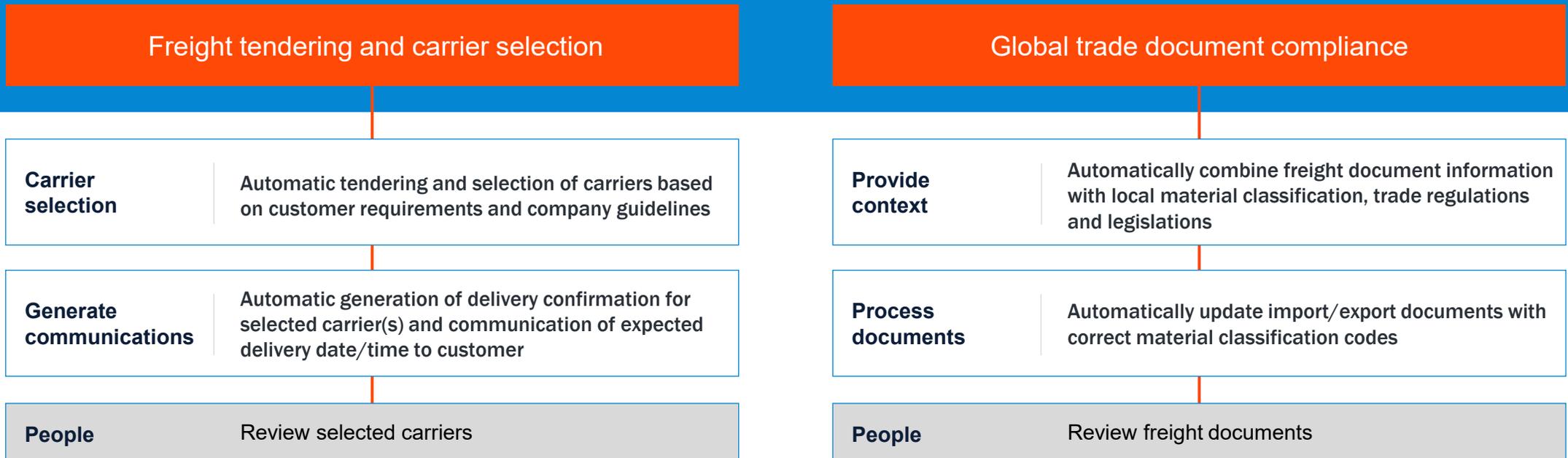
Agentic orchestration processes inbound shipment documents, schedules appointments and generates outbound shipment documents automatically





Transportation manager

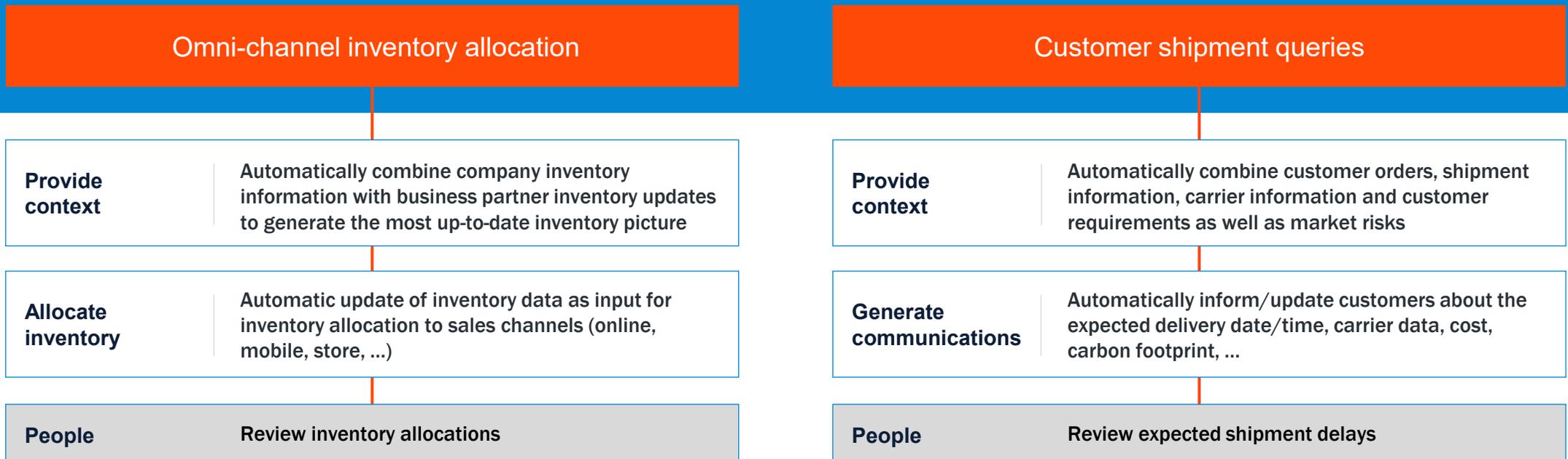
Agentic orchestration initiates carrier tendering, selects carriers, gathers expected time of arrivals, updates customers and ensures delivery compliance automatically





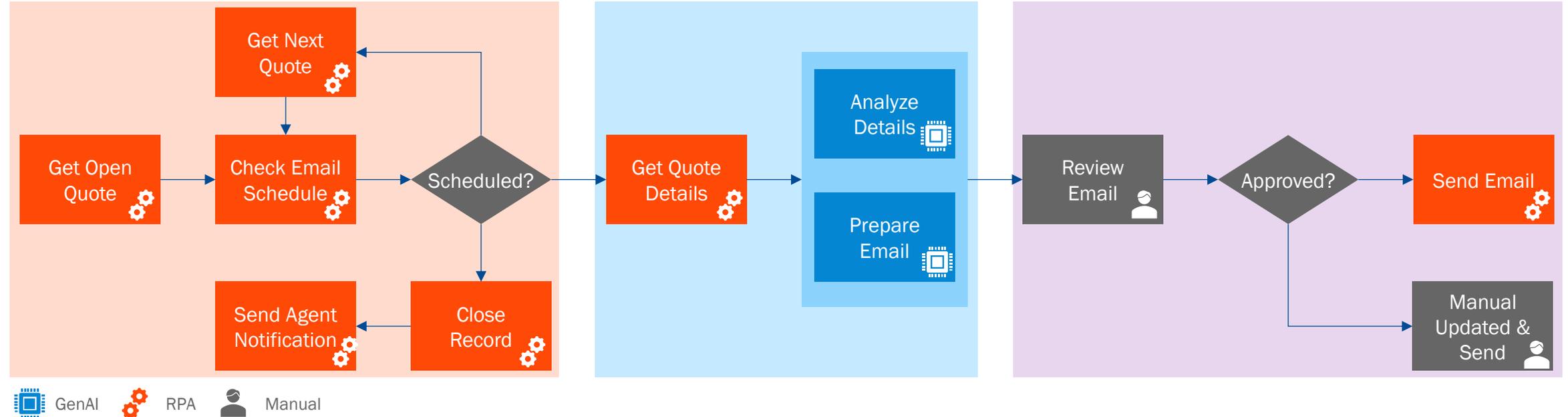
Distribution manager

Agentic orchestration enables the allocation of inventory to sales-channels for customer order confirmations and to update customers about the delivery status.



AI and Automation Solution Overview: Quotation Status and Follow-up

Our solution makes use of both RPA and LLM's to ensure each technology is being used to their strength: RPA for rule based, scheduled automation and LLM's for creative, tailored emails that require judgement



Step 1. Process Kick-Off

RPA initiates the process, checks email status and determines next steps:

- **Email Scheduled:** kick-off email generation
- **Post-Final Email:** close customer quote
- **Email Not Scheduled:** get next quote

Step 2. Generate Email

RPA & Gen AI get historical data and generate the email:

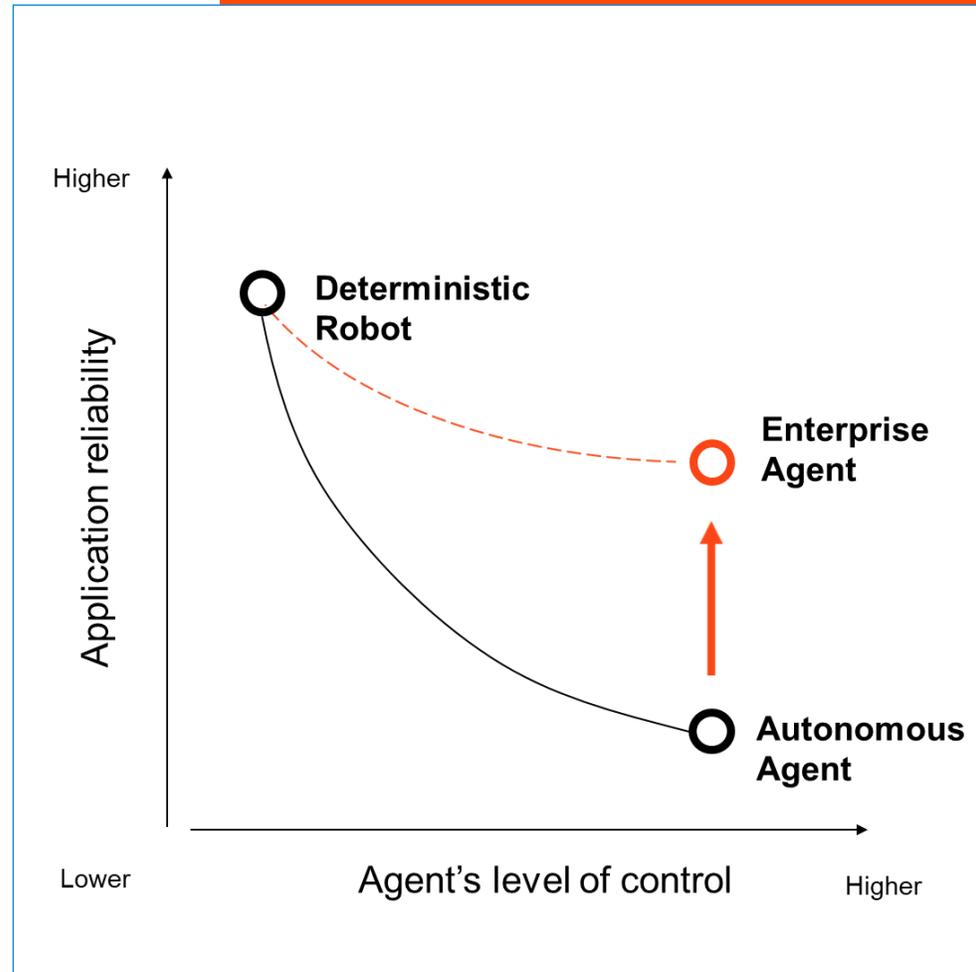
- RPA pulls data and generates email prompt
- GenAI tool analyzes input and prepares the email draft

Step 3. Approve and Send

The email draft is sent for timed-approval to an agent and can have the following outcomes:

- **Approved:** email is sent to customer
- **Rejected:** email is manually edited and sent
- **No Response:** email is sent once time expires

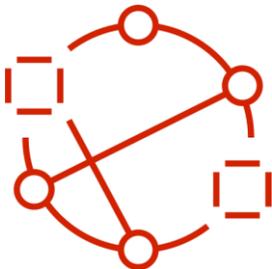

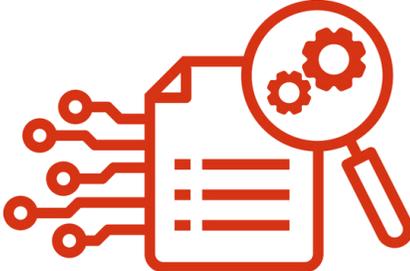
Important practices to adopt

- Exposing confidential information to public AI models is inviting a breach
- Audit trails for compliance

Measure AI Productivity



- Like people, have AI agents' accountability and responsibility
- How much better your outcomes are

Verify AI results using expertise and/or independent sources



- Treat AI as a team member who you manage
- AI may help validate other AI results
