1. **Complete the submission form.** Fill out all fields on the submission form, as this will avoid delays and/or unnecessary follow-up.
2. **Tell us how your presentation contributes to PIDX.** We want our attendees to have a meaningful experience at the conference, and one way of doing this is to select presentations that are highly relevant and valuable to the industry. Define clear goals that are easy to understand. Write your presentation description as if the reviewing committee knows nothing about you, your content or your background.
3. **Deliver new insights and ideas.** Don't recycle a presentation you've already delivered at another conference (unless modified).
4. **Share your real-world experience.** Consistently, our conference attendees tell us the presentations they gain the most from are those that address real challenges and how they have been solved through innovations. We look for presentations that give attendees something they can take back and implement.

The following presentations will ***NOT*** be considered: Product-centric and/or a sales pitch you would give a customer. PIDX is an educational conference focused on creating standards by the industry, for the industry.

SUMMARY OF PIDX ANTI-TRUST POLICY

PIDX, Inc is committed to compliance with all applicable Anti-trust laws.

- Conversations must be related to the published agenda and PIDX's mission, which is to provide a global forum for delivering the process, information and technology standards that facilitates seamless, efficient electronic business within the Oil and Gas Industry and its trading community.
